I. General Intellectual Property Notice

III. Common Law Rights and Goodwill

In addition to the marks identified above, Cordant owns and asserts common law trademark and service mark rights that arise from and are established by Cordant's continuous, exclusive, and extensive use of its marks and trade dress in commerce throughout the United States. These common law rights exist independently of any registration and attach to all marks, trade names, design marks, logos, taglines, trade dress, and brand identifiers used by Cordant, or by any predecessor, successor, successor-in-interest, assignee, parent, subsidiary, affiliate, or other related entity, in connection with its goods and services.

Cordant's common law rights are supported by and commensurate with the substantial goodwill developed through Cordant's continuous operations since at least as early as 2015,

including the processing of close to 4 million specimens tested annually, the establishment of a national network of collection sites, and Cordant's reputation for reliable, legally defensible drug testing results and innovative technology solutions in the toxicology, behavioral health, and criminal justice sectors. This goodwill encompasses all goodwill developed, acquired, or accumulated by any predecessor entity, predecessor-in-interest, successor, successor-in-interest, assignee, parent company, subsidiary, affiliate, joint venture partner, or other related entity at any time, whether before or after the formation of Cordant, and whether arising under the same or different marks, trade names, or brand identifiers. All such goodwill has inured to the benefit of Cordant and its marks by operation of law, assignment, merger, acquisition, equity purchase, reorganization, or otherwise, and is deemed part of and inseparable from Cordant's common law rights.

The goodwill associated with Cordant's marks is an asset of Technical Resource Management, LLC (and its predecessors, predecessors-in-interest, successors, successors-in-interest, assignees, parents, subsidiaries, affiliates, and all other related entities, whether direct or indirect) and is inseparable from the marks themselves. This includes, without limitation, all goodwill that originated with, passed through, or was held by any entity in Cordant's chain of title, chain of ownership, or corporate lineage, regardless of whether such entity currently exists or has been merged, dissolved, converted, or otherwise reorganized. Any transfer, assignment, or license of Cordant's marks includes the associated goodwill unless otherwise expressly stated in writing.

IV. Cordant SentrySM Intellectual Property

Cordant SentrySM is a proprietary, secure, HIPAA-compliant drug testing management platform developed and owned exclusively by Technical Resource Management, LLC. The Cordant SentrySM platform and all associated intellectual property are subject to the protections set forth in this Notice and further described below. Cordant asserts and reserves all rights in and to the Cordant SentrySM platform, including without limitation all trademark and service mark rights, copyright interests, trade secrets, and proprietary methodologies.

A. Cordant SentrySM Trademark and Service Mark Rights

The CORDANT SENTRYSM mark is a trademark and service mark of Technical Resource Management, LLC, used in connection with:

- (a) providing online non-downloadable software as a service (SaaS) for drug testing case management, including scheduling, participant management, automated notifications, test result reporting, compliance monitoring, and coordination of care workflows;
- (b) software as a service (SaaS) for drug testing program management, participant monitoring, and compliance reporting;

- (c) software for drug testing data analytics, including reports, data visualizations, compliance analytics, and program performance metrics;
- (d) data analytics services for behavioral health providers, treatment programs, judicial agencies, specialty courts, government agencies, and healthcare organizations; and
- (e) all related cloud-based technology services, workflow tools, system-of-record functions, and evidence-based program management solutions.

B. Cordant SentrySM Copyright Interests

Cordant owns all copyrights in and to the Cordant SentrySM platform, including without limitation:

- (a) All source code, object code, software architecture, and compiled applications constituting the Cordant SentrySM platform;
- (b) All user interface designs, screen layouts, workflows, navigation structures, and visual elements;
- (c) All documentation, user guides, training materials, and help content;
- (d) All data visualizations, report templates, dashboard designs, and analytics output formats;
- (e) All algorithmic implementations, data models, database schemas, and system configurations; and
- (f) All updates, upgrades, modifications, enhancements, and derivative works of the foregoing.

The Cordant SentrySM platform incorporates confidential and proprietary technology, trade secrets, know-how, and related intellectual property of Technical Resource Management, LLC and its affiliates. These protected assets include the platform's underlying architecture, data processing and analytics capabilities, automated workflow and notification functionality, secure reporting tools, and program-management features, together with proprietary methods used to support monitoring, reporting, compliance, and coordination among authorized program stakeholders. Nothing in this summary limits Cordant's rights in any patents, copyrights, trade secrets, trademarks, service marks, know-how, confidential information, or other intellectual property embodied in or associated with the Cordant SentrySM platform.

V. LabsoftSM Intellectual Property

LabsoftSM is a proprietary Laboratory Information Management System (LIMS) developed, owned, and continuously maintained exclusively by Technical Resource Management, LLC. The LabsoftSM system and all associated intellectual property are subject to the protections set forth in this Notice and further described below. Cordant asserts and reserves all rights in and to the LabsoftSM system, including without limitation all trademark and service mark rights, copyright interests, trade secrets, and proprietary methodologies.

A. LabsoftSM Trademark and Service Mark Rights

The LABSOFTSM mark is a trademark and service mark of Technical Resource Management, LLC, used in connection with:

- (a) proprietary laboratory information management software for laboratory workflow management, specimen tracking, data processing, automated laboratory operations, and result reporting;
- (b) software for laboratory process optimization, operational efficiency, quality assurance, and regulatory compliance in connection with toxicology and drug testing services; and
- (c) all related laboratory automation tools, station-specific user interfaces, barcode-driven workflow systems, and integrated laboratory management solutions.

B. LabsoftSM Copyright Interests

Cordant owns all copyrights in and to the LabsoftSM system, including without limitation:

- (a) All source code, object code, software architecture, and compiled applications constituting the LabsoftSM system, including all versions, builds, and iterations developed since 2001;
- (b) All user interface designs, station-specific screen layouts, workflows, navigation structures, and visual elements;
- (c) All documentation, technical specifications, user guides, training materials, and operational content;
- (d) All algorithmic implementations, data models, database schemas, automation logic, and system configurations; and
- (e) All updates, upgrades, modifications, enhancements, and derivative works of the foregoing, including all modernization efforts and platform evolution.

C. LabsoftSM Trade Secrets, Proprietary Technology, and Protected System Capabilities

The LabsoftSM system incorporates confidential and proprietary technology, trade secrets, know-how, and related intellectual property of Technical Resource Management, LLC and its affiliates. These protected assets include the system's underlying architecture, proprietary laboratory workflow methodologies, process optimization algorithms, automation strategies, operational efficiency techniques, barcode-driven processing systems, station-specific interface designs, scalable infrastructure configurations, and integrated development-operations collaboration methods. Labsoft's design principles, operational methodologies, and continuous-improvement processes constitute valuable trade secrets developed over more than two decades of dedicated investment. Nothing in this summary limits Cordant's rights in any patents, copyrights,

trade secrets, trademarks, service marks, know-how, confidential information, or other intellectual property embodied in or associated with the LabsoftSM system.

- (e) Copying, scraping, harvesting, or extracting data, content, reports, or analytics from Cordant's websites, platforms, or systems beyond what is expressly authorized;

Cordant may, in its sole discretion, report counterfeits, infringing listings, unauthorized uses, and misappropriation to platforms, registrars, payment processors, marketplaces, law enforcement agencies, and other relevant authorities.
